

GENERAL INFORMATION:

Mole Out can be used effectively to repel moles from lawns, gardens, flower beds, around playgrounds, golf courses, and other recreational turf areas.

DIRECTIONS FOR USE:

This product can be applied directly from this bag or from lawn spreaders. The product may be applied to either wet or dry areas and should be applied in early Spring, Summer and Fall.

Initial Application: Apply 1 tablespoon full of Mole Out directly into the mole runway (tunnel) at approximately 5' intervals by punching a 1" hole into the mole runway. After applying the product into each hole, cover the hole with soil. Flatten all runways by walking on them. Upon completing the above procedure, apply Mole Out at the rate of 1lb per 250 sq. ft. (10lbs covers 2,500 sq. ft.). After Mole Out is applied, sufficiently water in the application with a garden hose or sprinkler.

Follow Up Applications: Apply in early Spring, Summer and Fall. Lightly sprinkle over area evenly.

Note: The area where product was applied should be thoroughly watered before the first mowing after product application, to prevent product from being picked up by lawnmowers.

STORAGE & DISPOSAL:

STORAGE: Store only in original container, in a cool, dry, and well-ventilated location inaccessible to children, and pets.
DISPOSAL: If Empty: Do not reuse this container. Place in trash or offer for recycling if available.
If Partly Filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

PRECAUTIONARY STATEMENTS:

Do not swallow. Avoid contact with eyes as product may cause eye irritation. Avoid prolonged contact with skin or clothing. Wash thoroughly with soap and water after handling this product. Remove contaminated clothing and wash before reuse. Avoid contamination of food or feed. Do not apply directly to water, or to areas where surface water is present or to inter-tidal areas below the mean high water mark.

STATEMENT OF PRACTICAL TREATMENT:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first five minutes, then continue rinsing eye. If irritation persists, call a physician for treatment advice.
IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. If irritation persists, call a physician for treatment advice.
